The Vulnerable Workers Task Group is comprised of six employer representatives and six worker representatives, all of whom have been named to serve by Ontario Chief Prevention officer George Gritziotis. The Task Group will examine workers that have "a greater exposure than most workers to conditions hazardous to health and safety and who lack the power to alter those conditions," including immigrant and youth workers, as well as temporary foreign workers. Vulnerable workers and small businesses have been two groups identified that would benefit from more involvement with the health and safety system.

"The expert panel report noted that worker vulnerability arises for various reasons: not knowing one's rights under the Occupational Health and Safety Act such as the right to refuse unsafe work; having no work experience or training that is jobor hazard-specific; and being unable to exercise rights or raise health and safety concerns for fear of losing one's job, or in some cases, being deported," says the Chief Prevention Office.

Dawn Tattle serves on the Board of Directors of the Toronto Construction Association. In addition, she is a member of the Heavy Construction Association of Toronto.
